President's Report



Like many of you, I would like to see a very strong alumni association in the next 3 years and beyond. Aside from a solid camaraderie and collegial relationship among members, there is no denying that the strength of any similar organization is largely dependent on its financial assets. As such, we will be spending the next 3 years building our financial capability. As founding officers and members of the alumni association, we have the great task of ensuring the perpetuation of our association so it continues to be a strong and dynamic partner of our College and University today and in the generations to come. It is indeed a unique honor on our part to be given the chance to initiate this endeavor.

In August 2015 we started gathering the alumni online via our Facebook group site. We were able to gather around 500 Augustinian pharmacists and medical technologists outside the Philippines in just a few days. Our officers have been meeting online to plan and execute our activities. On September 17, 2015, the USAPMTIAA was successfully incorporated in the State of Missouri, USA. It was granted 501(c)3 status by the US IRS on October 14, 2015, classifying it as a non-profit charitable organization. Membership registration was initiated at \$25 annually and we were able to recruit around 90 active members as of June 2016.

The Board has laid down a three-year development plan to help shape the future of our organization. However, before we can successfully engage the alumni into working for our common goals, it is important to strengthen our bonds with each other. In order to achieve this, we have included a biennial meeting and reunion as a regular undertaking of the association. The first one will be held in Las Vegas, Nevada and preparations have been running smoothly and in a coordinated fashion largely because of the passion of many officers and members toward our alumni association and our Alma Mater. Close to 60 alumni mostly in the US and Canada will convene on June 25, 2016 at South Point Hotel in Las Vegas.

The following is the three-year development plan approved by the USAPMTIAA Board.

Building Our Financial Resources: Establishing a Strong Alumni Endowment Fund (AEF)

An endowment fund is a permanent invested fund set up in such a way that the capital remains intact while the gains or return of investment is utilized to finance the projects of the organization.

The yearly gain or return of investment is variable but averages about 5%. For example, if we have a \$100,000 endowment fund, every year we are looking at \$5,000 (or roughly P200,000) budget allocation for whatever projects and programs our organization will undertake. In most institutions, only a fraction of this gain is budgeted. For example, we can use 70% of this for our project and 30% goes to the endowment fund to ensure growth and perpetuity of the fund.

For you to appreciate the importance of endowment funds in the life of an alumni association, I will give you some examples. As the first example, the UP Medical Alumni Society of America founded in the 1980s currently has around \$6.5 million in its endowment and about 5% of that (roughly \$325,000 or about P13,000,000!) is donated to UP every year to finance their projects and programs. The UST Medical Alumni Association of America founded in the 1990s has around \$4 million in its endowment. These are very strong Filipino alumni associations here in the US and we can certainly learn from their experience. To illustrate further the importance of endowment funds and to see where we are at currently, Harvard University has more than \$36 billion in its endowment! Although it has to be noted that Harvard's endowment fund has been around for over 400 years! Yale University has around \$23 billion in its endowment! Most of these endowments come from their generous alumni. As you can see, this endowment fund is indeed a time-tested strategy for success of any non-profit organization – something that really demands our priority at this time.

If this materializes, ours will be the very first endowment fund that an Augustinian alumni association will establish. We hope to create a model financial resource that will attract other colleges in the University and entice them to create their own thereby pooling more alumni support for the University of San Agustin.

Strategies:

We have already approved through our bylaws that 60% of our membership fee (\$15) will go to our General Fund, while 40% (\$10) will go to our Endowment Fund. Assuming a conservative estimate of 100 members contributing to our association annually, we expect this year to get \$1,000 for our Endowment Fund. In 3 years' time, we expect around \$3,000 (5% of this is only \$150). This appears to be a very slow and less efficient strategy.

Since we have very demanding jobs as pharmacists and medical technologists, we cannot rely on fundraising activities such as

bingos, raffles, etc. We just really have no common time for these.

As such, the next and the most important strategy - one that we shall focus on in the next 3 years - is the launching of an Alumni Endowment Fund Drive. The goal of this fund drive is to reach \$100,000 or more by December 2017. This consists of reaching out to each international alumnus and soliciting pledges of financial support. We shall have 4 levels of support namely:

President's Circle of Donors	\$5,000 and above
Dean's Circle of Donors	\$2,500 to \$4,999
Circle of Benefactors	\$1,000 to \$2,499
Circle of Sponsors	\$300 to \$999

Why donate? There are 3 important incentives we shall give to the donors, namely:

- Alumni donating \$1,000 and above will be given a **special lifetime seat to the Alumni Endowment Fund Management Committee**. The committee which the Board shall create will manage the Alumni Endowment Fund and will decide on how the interest is going to be allocated. This gives our generous donors the right to decide on which projects their donations will go to.
- **Wall of Honor** – after December 2017, we shall arrange with the College and the University the construction of a large plaque to be mounted on the wall of the College Building. In this plaque which shall be called Wall of Honor (or something like that) shall be engraved the names of the donors to the Alumni Endowment Fund. The plaque shall be maintained in the wall of the College in perpetuity.
- **Life Member** – Member donors to the AEF will be awarded Life Member status to the association which means they will be exempt from annual membership dues. However, they still have the option to continue paying their dues if they really like to continue doing this.

How do we do this? We shall solicit pledges from the alumni and will adopt the following payment schemes:

- Payment of the pledge in whole before December 2016, or
- Payment of the pledge in 3 installments as follows:
 - 1/3 in December 2016
 - 1/3 in June 2017
 - 1/3 in December 2017

For example, if the alumnus desires to donate \$300, he can pay \$100 in December 2016, \$100 in June 2017, and \$100 in December 2017. In the same manner, if the donor wants to donate \$1,000 and earn a seat in the AEF Management Committee, he can pay \$350 in December 2016, \$350 in June 2017, and \$300 in December 2017. All these donations are tax-

deductible. We think this scheme is doable and should be easy for the alumni.

The goal of \$100,000 by December 2017 will require around 335 alumni donating \$300 each. There may be alumni who will donate more. There may be those who will donate less. Again, this amount we are asking may be big but this may be the only time you will need to donate this much since your donation will remain intact in the Endowment Fund and only its interest will be utilized to finance our projects.

When do we open an endowment fund? There is no minimum amount to open an endowment fund. But the Board suggests waiting until we have \$20,000 on hand before we set up an endowment fund.

By June 2016, during the First Biennial Meeting, we shall formally launch our Alumni Endowment Fund Drive. However, as early as now, since we already have our 501(c)3 status, the association will welcome any pledge of donation towards our Endowment Fund. Projects and Programs

Once we have established a strong financial resource, we will launch a series of short-term and long-term projects. We shall focus on 4 important areas as follows:

A. Student Development

Student scholarship and financial aid. We shall start with 1 scholar each for Pharmacy and Medical Technology (now called Medical Laboratory Science). We suggest that we commence sponsoring scholarships at the third year level when students have already committed to the Pharmacy or Medical Technology programs. In that way, we avoid wasting our financial support to someone who shall only change programs eventually. Of note, we already have established a similar program – one that is sponsored and initiated by individual alumni. In this **Alumni Student Scholarship Grants**, an alumnus chooses his or her scholar and provides the mechanics including the coverage for the scholarship. So far, we have 3 Med Tech scholars under this program.

Student training or travel grants. Sometimes, students will require financial assistance to travel or train somewhere related to their academic programs. This is another area our association can help.

B. Faculty Development

This is very important in helping the College strengthen its faculty profile. We shall eventually create faculty scholarships or professorial chairs to support a faculty member's academic and research pursuits. We shall also create travel grants and financial assistance for faculty training.

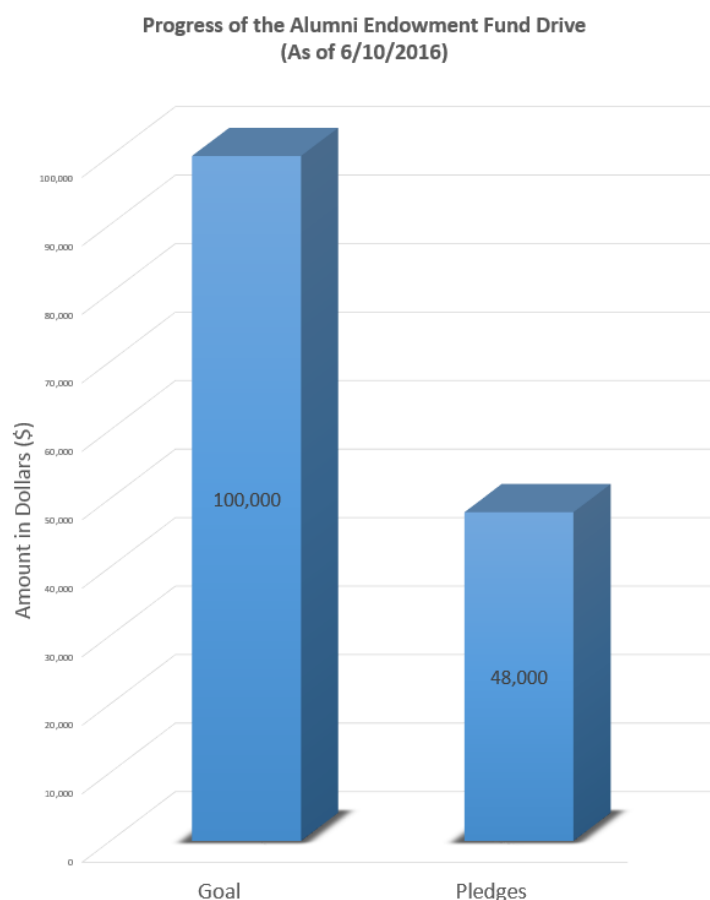
C. College Academic and Infrastructure Development

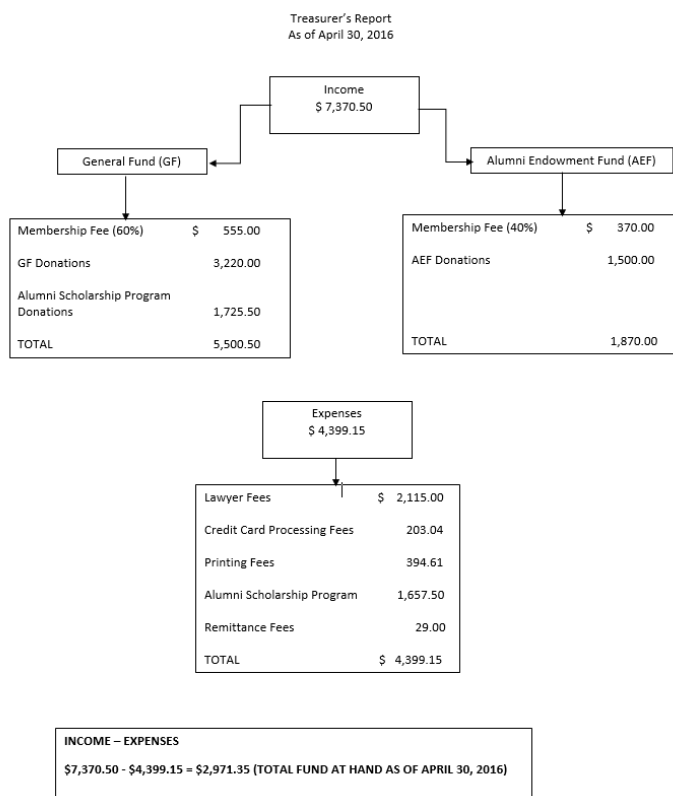

Treasurer's Report



Based on our constitution, our Total Fund is divided into the General Fund (GF) and the Alumni Endowment Fund (AEF). The General Fund is an unrestricted fund that we can use anytime to cover our day to day operations. The Alumni Endowment Fund is restricted and is meant to be invested. Only the interest will be made available to finance certain projects approved by our Board.

There are two important sources for our Fund namely:

1. Membership Fees – 60% of which goes to the GF and 40% goes to the AEF
2. Donations from our generous donors – These donations may be intended for the GF, the AEF or other allocations as specified by the donor (An example of this is the Alumni Scholarship Program where the donor indicates where his donation should go.)

As of April 30, 2016, we have accumulated a total of \$7,370.50 as our Income. \$5,500.50 of this went to our General Fund, while \$1,870.00 went to our Alumni Endowment Fund. At this time, the AEF and the GF are held together in a single bank account. Once our AEF is big enough, it will be placed in an investment.

As you can see, we have a total of \$4,399.15 for Expenses. These consist of:

1. Lawyer Fees – These were the fees we had to pay the lawyers when we registered our association

and secured our 501(c)3 status. These were taken from the donations to our GF by our generous donors.

2. The Credit Card Processing Fees – These are the fees we pay PayPal when our members pay online. It represents about 2-3% of their payments.
3. Printing Fees – These were incurred during the printing of the statements we had to send the alumni in the hope that they were able to send back their membership forms and fees. Again, we had donors who specifically donated money to cover these printing fees.
4. Alumni Scholarship Program – We have 3 scholars so far. Each of these scholars were chosen by the alumni who donated the fund for the scholarship program.
5. Remittance Fees – These represent the fees we have to pay PNB Bank which we use to transfer the fund to our scholars.

Overall, this is a good start. As of April 30, 2016, we have \$2,971.35 in our Total Fund. We are looking forward for more productive months ahead especially with our First Biennial Meeting and Reunion. Should you have any questions, please feel free to contact me directly. Thank you.

Ms. Gilda R. Rivero, former Dean of the College of Pharmacy & Medical Technology, is one of the most beloved and respected mentors known to many Augustinian alumni. She is one of the pillars of the College responsible for building the reputation of the University of San Agustin as one of the top universities producing quality professionals in Pharmacy and Medical Technology in the Philippines.

The strength of her character as a person has been largely shaped by the guidance of her wonderful parents, Judge Eusebio Rivero and Mrs. Estelita Rivero. As a student, she was always at the top of her class. She had been a consistent honor student, having graduated First Honors year after year while at Valderrama Antique Elementary School. During her high school, she graduated First Honorable Mention at the University of San Agustin High School Department. She finished BS Pharmacy Magna Cum Laude at the College and eventually topped her Board examination in Pharmacy, a first in the history of the University.

While there may be vast enticing financial opportunities awaiting the top pharmacy graduate of her time, her love for teaching and the magnitude of the influence of her mother, who herself was a school teacher, made her decide to stay at the University of San Agustin to begin a career in education that can only be described as illustrious, meaningful, and rewarding. While teaching at the College, she completed her MS Pharmacy at the Centro Escolar University in Manila. Her tenacity and resolve rewarded her with the Graduate Program's High Distinction for Outstanding Research Paper. To enhance further her teaching and clinical skills, she has attended both local and international trainings and seminars including the Catholic Educators Congress in Anaheim, California, the UNESCO Pharmacological, Microbiological and Phytochemical Screening of Medicinal Plants in Seoul University in Korea, and the Bioethics and Adverse Drugs Reactions Training in San Francisco, California.

Ms. Rivero has spent most of her career as a faculty in the College. From being a chemistry laboratory instructor, she rose through ranks to become the successor of Dean Emeritus Flora S. Salas as Dean of the College from 1994-2004. Outside the academe, she is very active in professional and religious organizations. She is a former President of the Iloilo Pharmaceutical Association and the Drugstores Association of the Philippines Guimaras-Iloilo Chapter. She is the current President of the USA Pharmacy and Medical Technology Alumni Association. She was the President of the Community-Based Apostolate of St. Joseph Regional Seminary in Iloilo City, and also the Head of the Teaching Ministry – Bukas Loob sa Diyos Covenant Community-Jaro District.

Ms. Rivero is the recipient of numerous awards including the University of San Agustin Outstanding Graduate Award, USACPA Outstanding Graduate Award, Philippine Pharmaceutical Association Award for Outstanding Graduate, The Philippine Professional Regulation Award as First Place Board Topnotcher, the United Laboratories Incorporated Outstanding Graduate Award, The Centro Escolar University Outstanding Graduate Research Paper Award, the USA Phar-Med Tech Outstanding Faculty Award, Bugal kang Antique Award, Pride of Valderrama Antique Award, and the Outstanding Achievement in Community-Based Apostolate Award from St. Joseph Regional Seminary.

Her career has been characterized by an exemplary commitment to teaching as well as community and religious involvements. She has been well-liked by her students and well-respected by her peers. The story of the College of Pharmacy and Medical Technology will never be complete without the mention of her significant contributions to the education of pharmacists and medical technologists who helped shape the practice of these professions in the Philippines most especially in Western Visayas.

Constitution & By-laws

Approved by the Board on September 15, 2015

I. Name

The organization shall be called University of San Agustin Pharmacy and Medical Technology International Alumni Association (USA-PMTIAA).

II. Purposes

The organization is organized exclusively for charitable and educational purposes with the College of Pharmacy and Medical Technology of the University of San Agustin in Iloilo City, Philippines as its primary beneficiary. Its objectives are:

- A. To promote the advancement of Pharmacy and Medical Technology nationally and internationally
- B. To unite all alumni of the College of Pharmacy and Medical Technology outside the Philippines, in helping the College achieve its goals and objectives
- C. To work harmoniously with similar organizations in promoting the welfare of the University of San Agustin particularly the College of Pharmacy and Medical Technology.
- D. To the extent that the activities of the Corporation may create a surplus of funds, donate all or part of such surplus to other organizations organized and operated for similar exempt purposes or other charitable and educational purposes qualified as tax exempt under 501(c)(3) of the United States Internal Revenue Service.

III. Membership

- A. The members of the Organization are graduates of the USA-CPMT who are presently or had previously resided outside the Philippines. Applicants for membership must be residents outside the Philippines at the time of filing their applications.
- B. Each member is required to pay annual membership dues to be labeled current or in good standing, and to be able to exercise membership rights. Annual membership fees shall be paid no later than every 31st day of January.
- C. The Treasurer shall prepare an official list of members and submit it to the Board annually on or before the last day of February.

IV. Officers and Board of Directors

- A. The Officers of the Organization shall include the following

- a. President
- b. Vice President for Pharmacy
- c. Vice President for Medical Technology
- d. Secretary
- e. Treasurer
- f. Assistant Treasurer
- g. Auditor

- B. The Board of Directors shall include the following

- a. Chair, BOD
- b. Vice President for Pharmacy
- c. Vice President for Medical Technology
- d. Secretary
- e. Treasurer
- f. Assistant Treasurer
- g. Auditor
- h. Representative from US West Coast
- i. Representative from US Central
- j. Representative from US East Coast
- k. Representative from Hawaii/Guam area
- l. Representative from Canada West Coast
- m. Representative from Canada East Coast
- n. Representative from Australia/New Zealand
- o. Representative from Europe
- p. Representative from Middle East
- q. Representative from Asia (outside the Philippines)
- r. Immediate Past President of the USA-PMTIAA

- C. The Officers and Members of the Board of Directors shall hold office for two years. The President and the Chair of the Board cannot be re-elected for a consecutive term

- D. The Board of Directors shall be the policy making administrative body of the Organization. The President shall act as the Chair of the Board.

- E. The Board of Directors shall hold a physical, virtual meeting or a teleconference at least every 6 months.

V. Duties of Officers and Board of Directors

- A. President

The President is the chief executive and titular head of the organization. S/He shall perform all duties incident to the office of the President. S/He shall perform all duties as may be designated by the Board of Directors.

The President shall preside over the meetings of the organization and the Board. The President shall also act as the chair of the Board.

S/He shall have the power to fill in any elected position, subject to approval of the 2/3 of the members of the Board.

- B. Vice President for Pharmacy

After an agreement with the Vice President for Medical Technology, the Vice President for Pharmacy shall perform the duties of the President in the event of absence or incapability of the President and to assume the Presidency of the organization, after the termination of office of the President.

- C. Vice President for Medical Technology

After an agreement with the Vice President for Pharmacy, the Vice President for Medical Technology shall perform the duties of the President in the event of absence or incapability of the President and to assume the Presidency of the organization, after the termination of office of the President.

- D. Secretary

The Secretary shall keep the minutes of the meetings of the Board of Directors and the Organization and shall perform duties assigned by the President. S/ He shall keep an up-to-date roster of all members of the Organization. The Secretary shall have the duties of issuing notices of meetings and conducting the general correspondence of the Organization and the Board of Directors.

- E. Treasurer

The Treasurer shall receive and act as custodian of the funds of the organization. S/He is primarily responsible for the collection of the membership dues and other fees agreed upon by the Organization. The Treasurer shall furnish the Board the list of all members qualified to vote. The Treasurer shall submit a financial report during the Biennial meeting and all other meetings of the Board.

- F. Assistant Treasurer

The Assistant Treasurer shall assist the Treasurer in the performance of his functions. S/He shall assume the duties of the Treasurer in the event of absence or incapability of the Treasurer.

- G. Auditor

The Auditor shall be responsible for having the financial statements of the Organization audited and shall arrange, with the collaboration of the Treasurer, for external auditing of annual financial reports. The Auditor shall have access to all financial records of the organization.

- H. Chair of the BOD

The Chair of the BOD presides over the meeting of the Board.

- I. Members of the BOD

The rest of the members of the Board shall represent the alumni in the geographic areas designated by the Board. They attend the meetings of the Board and are granted the power to vote and participate in deciding on issues affecting the organization.

- J. Immediate Past President

The Immediate Past President shall serve as adviser to the Board of Directors.

VI. Committees

- A. The President, with the approval of the Board of Directors, shall decide on creating the committees he deems necessary in implementing the programs and projects of the organization during his term. The Committees will be co-terminus with the President. Membership of the committees will come from members of the Board of Directors.

VII. Meetings and Quorums

- A. General Meeting

- a. The organization shall conduct a general membership meeting every 2 years. The meeting shall be referred to as the Biennial Meeting. The date, time, and place of the meeting shall be determined by the Board of Directors. Officers, except for the immediate Past President, shall be elected by the members every two years during this General Meeting
- b. A special general meeting may be requested by the President upon approval of the majority of the members of the Board, or upon written request made by 25% of the all members in good standing.
- c. Notice of Meeting shall be given at least 1 month prior to the meeting.

- B. Board of Directors Meeting

- a. The Board shall meet every 6 months during the date, time and place determined by the Board. The meeting may be done in actual, virtual, web messaging or teleconference.
- b. Notice of Meetings shall be given at least 1 week prior to the schedule.
- c. Emergency meetings may be requested by the President. Notice shall be given at least 24-hours prior to the schedule.

- C. The majority of the members of the Board shall define a quorum.

VIII. Membership Dues

- A. The membership dues shall be \$25 a year. 60% will go to the General Fund and 40% will go to the Endowment Fund.

- B. The membership dues may be changed by a majority vote of the Board.

IX. Fund

- A. The organization's fund will be subdivided into a General Fund and an Endowment Fund.

- B. The General Fund will be the immediate source of fund for the organization's routine and special operations.

- C. Only the annual interest of the Endowment Fund shall be available for projects and programs approved by the Board of Directors.

X. Amendments

- A. Amendments to this constitution and by-laws may only be done after approval of 2/3 of the members of the organization during its General Meeting.

- B. Any proposed amendment shall be approved first by majority of the Board of Directors prior to presentation to the members during the General Meeting. A notice of the proposed amendment shall be given each current member at least 1 month prior to the General Meeting.
